This form must be completed by current high school students who are applying to Purdue West Lafayette as undergraduate, nondegree-seeking students on the Purdue campus or through Purdue's dual credit program for students in participating high schools.

High school students who would like to attempt college-level coursework are required to submit this form to confirm parental/guardian consent and acknowledgement of the fees associated with Purdue courses, and to provide certification from a high school guidance counselor (or designated school official) that the student is capable of successfully completing the coursework. In addition to this form, high school students also must submit a recent high school transcript to the Office of Admissions.

Fees may be waived only for students in the dual credit program who are eligible for free or reduced lunch through the National School Lunch Program (NSLP). By applying to the dual credit program and signing this form, you grant permission for the school/school corporation to share information about your eligibility for free or reduced lunch with Purdue.

Undergraduate Nondegree and Dual Credit applications are not considered complete until this form and a recent high school transcript have been received by the Office of Admissions.
